## What is this product?


**Type:** The fund is an open-ended investment company organised as a “société anonyme” under the laws of the Grand Duchy of Luxembourg and qualifies as a “Société d’Investissement à Capital Variable” (“SICAV”) and a “Fonds d’Investissement Spécialisé” (“SIF”).

**Objectives:** The fund aims to achieve aggressive growth of capital with moderate to high volatility and moderate correlation to the broad equity markets. In order to manage the overall volatility of its investments, the fund primarily invests directly and/or indirectly with portfolio managers employing activist investment strategies to varying degrees. Investment funds that follow an activist strategy generally invest in publicly traded equity securities of companies whose equity securities are listed on a securities exchange (including NASDAQ), including privately-negotiated investments in such publicly traded equity securities and then seek to create additional fundamental value at these portfolio companies by working with management to seek to improve the strategy and operations of these companies and by otherwise applying the tools and rights of active and constructive ownership. Examples of the activities of a portfolio manager following an activist strategy may include engaging in proxy contests and seeking board representation on an underlying target company. Investment funds included in the fund’s portfolio may engage in activist strategies on a regular or more selective ongoing basis, depending on their respective stated investment mandates. In addition to activist strategies, portfolio managers may engage in a variety of other event driven strategies. The fund will initially seek to invest its assets in 4 to 8 investment funds (“underlying funds”), but may invest from time to time in a greater or lesser number of investment funds provided that it will invest its assets in at least 3 investment funds. The investment manager will seek to typically allocate equally among the investment funds, but as a result of individual investment fund performance, fund subscription and redemption activity and other factors, the actual allocation among the investment funds can be expected to vary. The investment manager expects that no single investment fund will account for more than 45% of the fund’s net assets at the time of investment, but the investment manager retains the discretion to invest more than 45% (but less than 85%) of the fund’s net assets in a single investment fund at the time of investment so long as it doesn’t breach the fund’s investment restrictions. The directors hold the right to arrange leverage of the fund’s portfolio to seek to enhance returns to shareholders, for cash management purposes and to facilitate redemption payments. The return of the fund depends on the performance of the investments mentioned above. The risk and reward profile of the fund is directly related to the recommended holding period and assumes you will hold the fund for such period, as set out below. For full details on the objectives of the fund, please refer to the prospectus of the fund.

**Intended Retail Investor:** The fund is intended for investors who seek aggressive growth of capital and absolute returns and who are willing to subject their investment to increased risk and potentially longer-term investments in order to potentially generate a greater rate of return. It is intended that the fund will be marketed and sold to retail investors within the UK who fall within one of the exemptions under section 4.12.4 of the UK Financial Conduct Authority’s Conduct of Business rules and the fund is only intended for investors who are prepared (i) to hold the investment for an indefinite period, and (ii) to potentially lose their entire investment and are prepared to sustain such loss. The minimum initial investment is USD175,000 followed by a subsequent minimum investment of USD50,000, although the fund board reserves the right to accept lower minimum investment amounts. The investor must have experience and a good understanding of fund of funds investments and their inherent risks. In addition, investors shall adhere in writing to the status of well-informed investors within the meaning of Directive 2004/39/EC or a management company within the meaning of Directive 2001/107/EC stating that they have enough experience to appreciate in an adequate manner an investment in the fund. Ownership of shares of the fund will be limited to “qualified eligible persons” (as defined in CFTC Rule 4.7). Ownership of the shares of the fund by “U.S. persons” (as defined in Regulation S promulgated under the Securities Act) will be limited to “accredited investors” (as defined in Regulation D promulgated under the Securities Act) and “qualified purchasers” (as defined in the Investment Company Act). It is generally expected that U.S. persons that are subject to taxation in the United States will not find the fund to be a suitable investment vehicle, so that investment by U.S. persons is expected to be limited to certain tax-exempt accounts.

**Term:** The fund has an unlimited duration, with no maturity date. The manufacturer, Citi Private Advisory, LLC, is not entitled to terminate this fund unilaterally. This fund cannot be automatically terminated but the redemption of your shares can be suspended or forced redeemed following board approval.

## What are the risks and what could I get in return?



The recommended holding period is 3 years. The risk indicator assumes you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have sell at a price that significantly impacts on how much you get back.



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or that the fund is not able to pay you. We have classified this product as 5 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the fund to pay you. An investment into the fund constitutes a speculative investment (some or even all of the capital invested could be lost and is only suitable for persons who can withstand such losses).

**Be aware of currency risk. As the base currency of the fund is USD, you will receive payments in a currency that may differ from your base currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.**

This product does not include any protection from future market performance so you could lose some or all of your investment. If the fund is not able to pay you what is owed, you could lose your entire investment.

## What happens if Citi Private Advisory, LLC is unable to pay out?

You may face a financial loss due to the default of the fund. These losses are not covered by an investor compensation or guarantee scheme.

## What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for the different holding periods, and include the costs of your advisor or distributor. They include potential early exit penalties. The figures assume you invest \$10,000. The figures are estimates and may change in the future.

## How long should I hold it and can I take money out early?

The recommended holding period of the fund is 3 years, subject to possible earlier termination pursuant to law or the terms of the fund. The recommended holding period of 3 years is based on the typical business cycle of the fund's underlying investments.

The minimum required holding period is four quarters from first quarter after the relevant subscription date by the investor. Shareholders desiring to redeem their shares must submit a written request to the administrator on or prior to 5 p.m. (Luxembourg time) by the 105th calendar day (or if the 105th calendar day is not a business day, the immediately preceding business day) before the relevant redemption date, set as the last business day of each calendar quarter. All investor redemptions will be limited to both investor level and fund level gates. Shareholders seeking to redeem their shares may request a redemption of a number of shares corresponding up to 25%, 33⅓%, 50% and 100%, respectively, of the then-current net asset value of their shares subscribed to on a given subscription date as of any four consecutive redemption dates (such 25%, 33⅓%, 50% and 100% amounts, the "Applicable Percentage" for a particular redemption date and such limitation, the "Investor Level Gate"). The fund may impose a fund level gate, limiting total redemptions as of any redemption date to 12.5% of the aggregate Net Asset Value of the fund as of that redemption date. Shareholders whose redemption requests are not satisfied in full on a redemption date because of the 12.5% limit will have priority over other shareholders subsequently requesting to make redemptions at subsequent redemption dates until the former shareholders' requests are satisfied in full. The fund will endeavour to pay at least 95% of redemption proceeds for the initial redemption date and each subsequent redemption date (subject to any reserves for expenses, liabilities or contingencies and net of any applicable management fee) to redeeming shareholders, without interest, within 30 calendar days after the finalization of the net asset value as of the relevant redemption date. Any remaining portion (subject to audit adjustments and any reserves for expenses, liabilities or contingencies) will be paid, without interest, within a reasonable time after the completion of the annual audit of the fund. There are currently no direct fees charged by the fund to shareholders associated with the redemption of shares in the fund. Please refer to the prospectus for full details on the redemption conditions. Redeeming your shares in the fund before the recommended holding period may be detrimental in terms of your return and may increase the risks associated with your investment, which may lead to the realisation of loss.
